



## TERMS & CONDITIONS

1. All cancellations must be communicated via email [info@sunrolley.com](mailto:info@sunrolley.com) five days ahead of your scheduled departure time to receive a refund. Credit card fees 5% (for an individual booking) or 10% (for a group larger than 7 participants) will not be refunded. Refunds will be issued within 12 to 14 calendar days. Tours cancelled with less than 5-days notice will not be entitled to a refund.
2. We cannot guarantee the ending time of the tour due to outside conditions beyond our control such as vehicular traffic, events and unexpected circumstances. Please plan accordingly.
3. Tours go on as scheduled, rain or shine! If the tour is cancelled, refunds will be provided.
4. There is no minimum age requirement. Children under two-years old, that stay seated in an adult's lap, ride free.
5. Please arrive 30 minutes prior to your tour start time. Our trolleys leave promptly at 10 a.m. with or without you, so please arrive by 9:30 a.m.

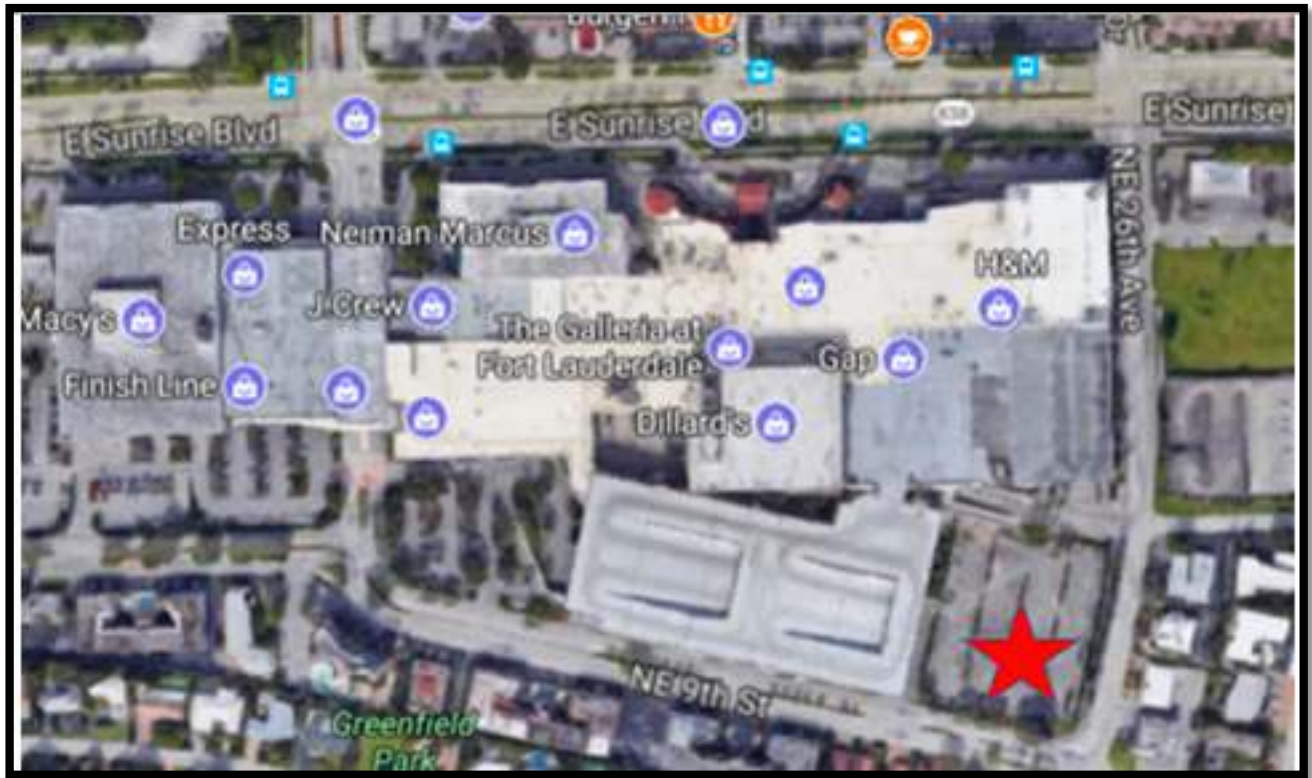
